# Legislative Biography

AZ Rep. Joseph Chaplik is a Representative in the Arizona State Legislature who represents the 3rd district and received 39.4% of the vote in his last election. He is the Chair of the Regulatory Affairs committee, and a member of the Capital Review and Budget committees.

He works most frequently on Law (95 bills), Crime and Law Enforcement (93 bills), Education (54 bills), Economics and Public Finance (53 bills), and Health (25 bills). He has sponsored 22 bills in his

last four year(s) in office, voting with his party 83.1% of the time, getting 63.64% of his bills out of committee, and 27.27% of his sponsored bills enacted.

Rep. Chaplik most frequently works on legislation with Jake Hoffman (R-AZ-15) (125 bills), Beverly Pingerelli (R-AZ-28) (112 bills), and Leo Biasiucci (R-AZ-30) (95 bills). He most frequently votes with Rachel Keshel (R-AZ-17) (90.36%), Ralph Heap (R-AZ-10) (89.66%), and Justin Olson (R-AZ-10) (88.97%).

Before entering politics, Rep. Chaplik was involved in business. He received a degree from Bowling Green State University (OH).

# **Critical Race Theory**

Here is an example of Representative Joseph Chaplik's social media posts misrepresenting Critical Race Theory to distort and, ultimately, silence arguments for racial justice & equality in the United States:

#### **QAnon**

## Other

**Chaplik falsely accused House Majority Leader Michael Carbone of throwing items from his desk during a heated disagreement.** Video evidence disproved Joseph Chaplik's accusation that Majority Leader Michael Carbone grabbed and threw items off his desk. According to the Daily Arizona Independent, "According to Arizona State Representative Joseph Chaplik, a disagreement with the House Majority Leader became so heated that the Leader, Michael Carbone, grabbed items

from Chaplik's desk on the House floor and threw them on the floor. Chaplik's accusation was quickly circulated throughout the Capitol by those looking to portray the Republican caucus in disarray. The charge prompted a House investigation that included a review of video of the House floor, which revealed Chaplik made up the charges. Carbone never grabbed or threw any of his items. 'Chaplik lied, and it was a dumb lie because, of course, there is video, so he got busted lying in full color,' said one Capitol insider." [Arizona Daily Independent, <u>02/15/2025</u>]

**Chaplik's co-sponsorship of House Bill 2031 is a direct assault on workers, consumers, and public services, all under the false pretense of "cutting government waste."** House Bill 2031, pushed by Chaplik and Rep. Alexander Kolodin, is legislation to reduce the number of state boards and commissions. The bill seeks to eliminate entities within the state's regulatory framework that are deemed outdated or redundant. This bill would dismantle critical oversight by eliminating state boards that regulate professional licensing, uphold workplace safety, and support essential public programs. It targets working-class professions like barbers and cosmetologists by stripping licensing requirements and threatening industry standards and worker protections. The bill also proposed the elimination of the Arizona Commission on the Arts. Established to support and advance the arts statewide, the commission provides grants and resources to artists, educational programs, and community initiatives. By championing this reckless deregulation, Chaplik is making it clear: his priority is gutting protections for workers and the public to serve an extremist anti-regulation agenda. **Chaplik's legislation, House Bill 2681 and House Bill 2439 are a direct attack on reproductive rights in Arizona.** HB 2681 imposes severe restrictions on abortion-inducing drugs, mandating in-person examinations, extensive documentation, and mandatory follow-up visits by physicians while also banning the distribution of these medications by mail or courier. The bill goes even further by introducing civil liability for violations, effectively punishing both physicians and patients. HB 2439 takes a different approach, forcing state health agencies to provide information on pregnancy support and adoption services, yet completely excluding any resources related to abortion care. Throughout Chaplik's career, he has supported numerous bills that restrict abortion access, including voting against repealing Arizona's outdated 1864 abortion ban and banning abortions after 15 weeks. Furthermore, he co-sponsored a bill requiring physicians to attempt to preserve the life of any infant born alive—despite the fact that infanticide is already illegal—and another that mandates public disclosure of companies that fund organizations advocating for abortion. **Chaplik co-sponsored Senate Bill 1098, which introduced restrictive measures on Arizona's election processes.** The bill requires individuals delivering early ballots to present identification and attest to their relationship with the voter, with violations punishable as a Class 5 felony. This provision could severely limit voter participation by creating unnecessary barriers for those assisting others with their ballots, particularly in communities with limited access to transportation or polling places. Additionally, SB 1098 mandates using state-owned facilities as voting locations starting in 2026, which could further limit access for marginalized communities. The bill also consolidates polling places and imposes stricter election regulations, complicating the voting process and increasing the likelihood of confusion and disenfranchisement. By supporting this bill, Chaplik is championing measures that undermine Arizona voters' right to accessible and fair elections. [AZ S.B. 1098]

Chaplik co-sponsored House Bill 2670, a deeply concerning piece of legislation that mandates fetal development instruction in Arizona's classrooms for students in grades seven and eight. The bill politicizes health education by introducing discussions on fetal development, despite the public's strong support for reproductive rights. It is part of a larger trend of legislation aiming to regulate what students are taught, particularly on sensitive topics like reproductive health. This bill mirrors efforts to bend educational institutions occurring at the national level. Critics of the bill, including lobbyists from Planned Parenthood Advocates of Arizona and Reproductive Freedom for All, noted that Arizona law does not require sex education in schools. They said they thought it did not make sense for the state to require instruction on fetal development without comprehensive sex education. These efforts will inhibit academic freedom and, in the case of the fetal development bill, open teachers up to prosecution. By supporting this bill, Chaplik is helping to impose ideological control over education, furthering the erosion of reproductive freedom in Arizona. [AZ Central, 03/03/2025, AZ H.B. 2670]

**Chaplik's co-sponsorship of House Bill 2438 represents a direct violation of individual rights and government overreach into personal identity.** By explicitly prohibiting changes to the sex designation on birth certificates due to sex change surgery, this legislation strips Arizonans of the ability to obtain accurate legal documentation, denying them recognition under the law. The bill not only eliminates a critical provision for those who have undergone gender-affirming procedures but also restricts judicial authority, barring pro tempore judges and commissioners from issuing orders to amend birth certificates under certain conditions. By supporting this measure, Chaplik is championing a policy disregarding personal freedom, medical realities, and the fundamental right to self-identification, setting a dangerous precedent for state interference in private lives. **Chaplik refused to investigate an ethics complaint against Rep. Austin Smith, shielding a fellow Republican from accountability despite serious allegations of petition signature fraud.** Smith, a far-right lawmaker and former Turning Point Action official, was accused of personally forging over 100 petition signatures to qualify for the 2024 ballot. The accusations were serious enough that state election officials referred them to the Arizona Attorney General's Office for possible criminal investigation. Despite this, Chaplik, who chairs the House Ethics Committee, dismissed the ethics complaint filed by Democratic lawmakers, arguing that the committee is not a law enforcement body and that the complaint lacked firsthand knowledge of wrongdoing. This weak justification ignores the committee's duty to uphold the integrity of the legislature and hold its members accountable. Instead of investigating, Chaplik effectively gave Smith a free pass, allowing partisan interests to override ethical responsibility. His inaction sends a clear message: Arizona's Republican leadership is more interested in protecting its own than ensuring transparency and accountability in government. [AZ Mirror, 05/20/2024] **Chaplik has become a central figure in Arizona's controversial push for harsh immigration legislation that many critics accuse of fostering racial discrimination and xenophobia.** By sponsoring bills that empower local authorities to arrest and deport migrants, Chaplik perpetuates a narrative that vilifies immigrant communities as the source of crime and societal issues. His support for legislation that echoes Arizona's notorious "show me your papers" law raises serious concerns about the potential for widespread racial profiling and injustice, further alienating vulnerable populations. As protests escalate, fueled by the outrage of Latino advocates and Democratic lawmakers, Chaplik's actions exemplify a troubling trend of exploiting immigration policy for political gain. Chaplik has marketed the proposals as a necessary defense against a wave of criminal activity, using xenophobic language to villainize migrants and accuse them of being responsible for a multitude of problems. **Chaplik promoted a debunked conspiracy theory alleging then-President Joe Biden of using a body double.** Chaplik reposted a claim from former journalist Sharyl Attkisson suggesting President Joe Biden was using a body double—an assertion with no evidence, pushed by figures known for spreading falsehoods. His actions mirror those of Sen. Wendy Rogers, who has promoted similar baseless claims. Chaplik's refusal to engage with fact-based discourse underscores a troubling pattern among Arizona's Republican leadership: a preference for political theatrics over truth. By spreading discredited conspiracies, Chaplik fuels distrust in democratic institutions and legitimizes dangerous fringe narratives. His silence in the face of multiple requests for comment only further confirms his lack of accountability. Rather than serving his constituents with integrity, Chaplik continues to indulge in the reckless spread of misinformation, prioritizing partisan sensationalism over responsible governance. **Chaplik co-founded the Arizona Freedom Caucus.** In 2022, Chaplik was among the four Arizona Republican legislators to found the Arizona Freedom Caucus, modeled on its federal counterpart in the U.S. House. The Freedom Caucus seeks to move the legislature towards far-right-wing extremism. [Axios, 7/25/2022]

**Chaplik is cosponsoring legislation to make illegally crossing the border a state crime, copying a controversial Texas law.** HB 2748, the Arizona Invasion Act, would make it a state crime for anyone to enter the United States from any foreign nation other than at a port of entry. As this is already a federal crime, it would authorize local or state police to enforce the law. According to KJZZ, "Texas is defending itself, and this bill will enable Arizona to defend itself at the border," Rep. Joseph Chaplik (R-Scottsdale) said. He's sponsoring one of three bills that copy parts of a Texas law the U.S. Department of Justice argues is unconstitutional. The Texas law is similar to Arizona's own infamous 2010 immigration policy, SB 1070. Key provisions of that law were thrown out by the U.S. Supreme Court, which ruled that Arizona has no right to enforce federal immigration laws." These cruel immigration bills are intended to intimidate and harm the vulnerable. HB 2748 is currently moving through the legislature. According to the Institute for Research and Education on Human Rights' special report, Breach the Mainstream: A National Survey Of Far-Right Membership In State Legislatures, Chaplik belongs to at least four far-right Facebook groups. This report documents public Facebook groups that espouse "election denial, COVID denial, anti-vaccine 'health freedom,' Islamophobia, antisemitic conspiracies, attacks on Black Lives Matter and Black history under the anti-'Critical Race Theory' banner, anti-abortion, 'groomer' anti-LGBTQIA bigotry, and even open appeals to white nationalism." The groups Chaplik is a member of include Arizonans For The Second Amendment, Arizona Patriotic Businesses, Moms for Liberty - Maricopa County, AZ, and Tea Party of Scottsdale. **Chaplik threatened to withhold funding from Arizona State University after wildly claiming "institutionalized racism and neo-segregation" had taken over the campus.** After a viral incident where two white students attempted to troll students of color with a "Police Lives Matter" sticker and claiming that "white" is a culture at ASU's multicultural center, where they were calmly asked to leave, 20 Arizona legislators drafted a letter attacking the University and threatened to withhold vital funding. The letter, signed by Rep. Joseph Chaplik, criticizes the incident as "Racially-motivated harassment of two students and their subsequent removal from one of the campus' study facilities that ASU has allowed a culture of institutionalized racism and neo-segregation to take hold on its campus." The signers of the letter vowed to take legislative action, including the threat of withholding funding to the university. [Prescott eNews, 10/5/2021]

#### Chaplik called for withholding funding from school districts that implement mask mandates.

The same day that three state universities announced they would implement mask mandates, 17 Arizona legislators wrote a letter to Governor Ducey calling for him to withhold federal funding to schools that implement such policies. The letter highlights preemption saying that local governments cannot make their own policies and the real issues of, "The Arizona legislature, with the governor concurring, very intentionally enacted the laws at hand to protect Arizonans and Arizona children from the threat of government mandating them to wear a mask or be injected with a vaccine." The letter publicly asks Ducey to withhold funding, provide Empowerment Scholarship Accounts to students, and initiate legal action in those school districts. The following week, Gov. Ducey announced education grants that can only be directed to schools without mask mandates, but the Treasury Department said these grants are "not a permissible use" of federal funding.
